Retention period personal data belonging to customers, suppliers and other contractors

If you requested an offer from us, but you did not become a customer of ours, we will retain your personal data for a term of at least two years after our last contact. If you did become our customer or we did become your customer, we will retain your personal data for a term of at least seven years after the end of the financial year in which the agreement with you was performed. The period of seven years corresponds to the period for which we are obliged to keep our records for the Tax and Customs Administration.

Security

Your rights

RECRUITMENT

Privacy

Brimotech BV would like to thank you for your interest in our company. We believe it is important to protect your personal data during the entire process. Below we explain which information Brimotech BV collects in applications and how this information is used.

Personal data

Personal data are specific data about personal or factual characteristics, related to a specific natural person or a natural person whose identity can be identified. This includes, for example, your name, address, telephone number, and personal number.

Use of personal data
